## **New Business**

**2023 Budget:** Emily Block presented the 2022 income and expenses as well as the 2023 budget. The leadership team reviewed the proposed 2023 budget and several minor changes were made. The proposed budget is for \$434.971. This budget will be e-mailed to the congregation and available at the budget meeting. Warren Harmon moved to accept the 2023 budget and Todd Johnson seconded the motion. All voted in favor.

**Review presentation for January 15 congregational budget meeting:** Emily Blain showed the presentation that she will be presenting at the 2023 budget meeting and minor suggestions were made.

Agenda for the Annual Meeting of the Congregation (January 29): Warren reminded the leadership that congregational members were invited to submit additional agenda items to him or Bob Westland by today and none were submitted. The agenda was developed based on prior agendas and current new business. Bob Westland made a motion to accept the agenda and Phil Kuper seconded the motion. All voted in favor.

**2023 Ministry Vision:** Pastor Ben led a discussion about possibilities including reducing staff costs, reducing building costs, increasing giving, increasing membership, and shared ministry with another congregation.
